## **Sheriff report:**

### **Cemetery report:**

-Enforcement of Decoration Violations: Julie McKee stated there are too many violations going on in both Harrison and Lakeside cemeteries. The fine to be imposed will be up to \$500 if after being contacted, the bricks, rocks, plants, glass, etc. are not removed. A portion of the ordinance will be posted in the paper and certain people will be contacted soon.
